

"Experience I Multidisciplinary Symposium of State Health Secretariat

of São Paulo in the Prevention and Treatment of Wounds – Brazil"

Introduction: The speed of change, the famous globalization and technological development continually transform the work environment, so that today there is no doubt that "study" and "training" are not just a stage of life, but a constant throughout the entire career. The professional development is extremely important, because every day new technologies are released, which makes it inevitable that the trader never interrupt your Training.

Objective: To report the experience of the I Multidisciplinary Symposium Secretariat of Health of São Paulo, in the Prevention and Treatment of Wounds, for health professionals.

Material and Methods: A descriptive and quantitative study, the sample was 261 participants who responded to the Evaluation "I Symposium Multidisciplinary of the São Paulo State Health Department for Prevention and Treatment of Wounds" which on May 5, 2015, the Rebouças Convention Center, in order to update health professionals in the prevention and treatment of wounds. Participated in organizing the event, 10 public health institutions belonging to the Secretariat of São Paulo State Health Department. The topics discussed at the event were: current landscape of wound; pressure ulcer; neuropathic ulcers; dilemma of not healing (role of the multidisciplinary team) and perspectives in the prevention and treatment of wounds in the State of São Paulo. A questionnaire to evaluate the event with seven questions was applied. **Results:** Participants total of 510 health professionals, public and private institutions, these 51.17% (261) responded to evaluation of the event. And the event evaluation results were: 96% considered the location and the great themes; 89.45% assessed as great a workload; 92.72% said that the organization was great; 100% reported that audiovisual resources were great; 92.72% assessed as great speakers and 98.46% responded that the event met their expectations. **Discussion:** The event had a multidisciplinary approach with nurses lecturers, doctors, nutritionists, physiotherapists, psychologists, occupational therapist and the participation of several health professionals among them, nurses, doctors, nursing assistants and technicians, veterinarian, dentist, nutritionist, assistant social, speech pathologist, biomedical, physical therapist, psychologist, apart from the companies involved in the prevention and treatment of wounds.





Conclusion: The work of a multidisciplinary team and updated in the Prevention and Treatment of Wounds is critical, requiring these professionals technical and scientific knowledge. Thus, we conclude that the in-service education for health professionals, aimed at training in its various areas are essential for the construction and improvement of knowledge. **Keywords:** Wounds; Multidisciplinary Team; Professional Development.
